Quarter in Focus

The year 2020 for IPS ended with an eventful quarter. The salient among its academic activities were its primary research projects: Forced Conversion or Faith Conversion: Rhetoric or Reality and Barriers and Drivers of Solar Prosumage: A Case Study for Pakistan. Alongside producing insightful briefs and media content on various policy issues, the Institute also held consultative sessions with relevant stakeholders and experts on its ongoing research projects.

A talk by former Prime Minister and veteran political leader of Afghanistan Engr. Gulbuddin Hekmatyar was another highlight of the quarter, whereas the issues like Durand line and 19 years of US' presence in Afghanistan were discussed in separate sessions, with the latter also featuring the launch of new IPS Press publication Afghanistan: Mulla Umar se Ashraf Ghani Tak authored by former ambassador Syed Abrar Hussain.

The Institute's initiative of 'Understanding Africa' featured a detailed session accentuating Pakistan's role in UN peacekeeping missions in Africa, while analysts and foreign policy experts contemplated over the matters like recognition of Israel, Basic Exchange Cooperation Agreement between the US and India, and the challenges for new US president-elect Joe Biden in other sittings.

IPS continued to highlight Kashmir cause not only with the twelfth meeting of its Working Group on Kashmir (IPS-WGK), but also through the presentations of its Executive President in the events organized by Institute of Strategic Studies Islamabad (ISSI) and the Legal Forum for Oppressed Voices of Kashmir (LFOVK).

IPS LEAD – the Learning, Excellence and Development program of IPS - organized a session 'Brainstorming Research Ideas: Media Studies' in collaboration with Riphah Institute of Media Sciences, held a sitting in continuation of its ongoing series 'The Living Scripts', and hosted an exposure visit of student leaders, also imparting them two-day training on leadership skills. The induction of 'Non-Resident Fellows' in IPS' research team was another significant step taken during the quarter, taking on-board senior academics from different universities as part of its 'Indigenizing Policy Research in Pakistan Initiative'.

IPS Press entered into an agreement with Kube Publishing (UK) to enable the readers in Pakistan and Afghanistan to buy low-priced reprint editions of all books of the popular UK-based Islamic publisher. Another book titled *Faraib-e-Na-Tamam* by renowned diarist Jumma Khan Sufi was also brought forth.



Only a sovereign Afghan government can avert another civil war after US withdrawal: Gulbuddin Hekmatyar

The only durable solution for peace in Afghanistan is that the US should withdraw its troops and a non-aligned, independent and sovereign government should be formed by Afghans in light of their beliefs and traditions without any interference; otherwise the country would slither into another civil war, warned veteran Afghan politician and Hizb-e-Islami's supreme leader Eng. Gulbuddin Hekmatyar.

He was addressing a large number of foreign

policy analysts, practitioners and journalists at his exclusive talk organized by IPS on October 21, 2020, at the conclusion of his three-day official visit to Pakistan on the invitation of the Ministry of Foreign Affairs.

The forum was chaired by EP-IPS Khalid Rahman and moderated by Amb (r) Syed Abrar Hussain. Pakistan's special envoy for Afghanistan Amb (r) Muhammad Sadiq was also present on the occasion.

Aimed to promote policy-oriented research, dialogue and human development in Pakistan in an 'indigenous' framework, and building a policy research community, IPS has taken another initiative to launch a Non-Resident Fellowship (NRF) program with effect from December 2020.

Hekmatyar said Afghans invested about \$20 billion in other countries including Turkey and the Gulf states during the war. He suggested that Pakistan should facilitate Afghan investors and businessmen thus enabling them to bring their investment to Pakistan. The facilities he termed essential in this regard include permission to open bank accounts, buy property on the basis of Afghan passports and long-term visas like those provided by certain European countries.

Pakistan to gain nothing by accepting Israel - IPS RTC

Issues as delicate as the recognition of Israel must be addressed in line with the popular opinion and sentiments in Pakistan and through parliamentary debates, as such a measure taken against the national ideology and policy environment will create chaos in the country. It was also deplored that the debate initiated on the issue in the policy arena by some vested interests is untimely and counterproductive as it does not present any vision and proactive plan to benefit from such a major foreign policy shift. Rather, Pakistan does not seem to gain anything by accepting Israel in material terms in the security or economic arena except causing a casualty of its own national ideology, which is the real binding force of the Islamic republic. This was the crux of a roundtable titled 'UAE's

The visiting delegation comprised IPS research team members Syed Nadeem Farhat, Ghulam Hussain Sufi and Hafiz Usama Hameed, whereas the participants from CII included the session's chair Dr İkram ul Haq, secretary, CII, Dr Inamullah, DG, CII, and the Council's senior research faculty.

Sufi delivered a presentation on the occasion titled 'Rhetoric of Forced Conversions in Pakistan: Legal and Policy Implications', which was based on an IPS study. He apprised the participants over how local and foreign NGOs twist facts and figures pertaining to faith conversion taking place mainly in Sindh, in order to pose the element of threat, fear and force behind the phenomenon. Even the incidents of voluntary conversion to Islam by adult and mature women, according to the presentation, were projected either as underage cases or as forced conversions following an abduction by local Muslims that was facilitated by Muslim clerics. These stories were then being used to malign the state, society and religious as well as cultural norms of Pakistan.





The narrative of 'forced' conversions of the minority communities to Islam in Pakistan has echoed nationally and internationally over the past several years, resultantly showing the country in a bad light. IPS initiated a baseline study titled 'Forced Conversions or Faith Conversions: Rhetoric and Reality' to look into the issue and understand its dynamics. It is hoped that this study will help to understand how the fabrication of facts is taking place and how certain daily life events are portrayed as

organized crimes and propagated out of proportion. It recommends that no policy decision should be based merely on the basis of some reports prepared by certain organizations and interest groups in order to safeguard the rights and dignity of everyone.
