Quarter in Focus

An IPS report based on a nationwide consumer survey highlighting the woes of rising electricity prices made rounds in the national media. The study, covering over 1100 residential and commercial consumers from across ten major cities of Pakistan, delineated the negative effects of rising prices that can lead to difficulties in paying for power purchases from the generation companies, maintaining distribution network, and servicing debts.

Targeted investments and digitization in electricity transmission infrastructure to ensure transparency, affordability and accessibility to consumers was proposed in another seminar.

The last quarter also saw IPS inviting international experts and scholars, especially from the US, to two distinct sessions to speak on the topics of the muffled international responses to Israeli aggression in the Middle East, and the growing challenges of identity crisis among Muslim youth, whereas the British-American lawyer for Dr Aafia Siddigui was also given the stage to have his say over the unending misery of the iconic Pakistani prisoner in the US. Besides, the ambassador of Sudan to Pakistan was also hosted to discuss the ongoing Sudan crisis in a hybrid session addressed by eminent national and international MENA region experts.

IPS partnered with the International Committee of the Red Cross (ICRC) to hold a workshop equipping the editors of Islamic publications with the conceptual understanding to report humanitarian crises.

Economic experts partaking in a budget review session advocated for a self-sustaining budget for Pakistan, whereas an IPS team visiting Islamabad Policy Research Institute (IPRI) discussed a draft report highlighting the issue of declining governance in the country.

IPS' faculty participated in various external discussions sharing their insights on aspects concerning Pakistan, Afghanistan, Kashmir and Palestine, while the Institute reached out to and hosted delegations from different academic and research institutions exploring opportunities for collaborative ventures.

The Institute produced as much as nine briefs and research reports in the period covering miscellaneous topics of national significance, in addition to bringing forth an issue of its flagship journal Policy Perspectives.



Humanitarian journalism is a humanitarian service: IPS-ICRC media workshop




budget-making rather than relying on loans. This was the view of various economic experts who participated in a session on May 24, 2023, which was organized to gain insights into the budget for the next financial year.

Weakening global response encouraging Israeli and Society must stay vigilant of Indian aggression: International webinar



A weakening global response due to systemic failures in global governance - under the UN's umbrella - is emboldening Israel and India to carry out aggression and human rights violations with impunity. This is clearly illustrated by the latest Israeli assaults on Palestinians in the Al-Aqsa Mosque compound which have failed to elicit any firm response beyond the routine statements of condemnation from the OIC, Arab League and a few countries.

These views were expressed during an international webinar titled 'Israeli Actions in the Middle East: Normalizing Aggression and Weakening Response' organized by IPS on April 13, 2023.

The forum was chaired by Ambassador (r)

Syed Abrar Hussain, vice chairman, IPS, while the speakers included Dr Hatem Bazian, chair, Islamophobia Research & Documentation Project, USA, Dr Zeenat Adam, deputy executive director. Afro-Middle East Centre, South Africa, Dr Chandra Muzaffar, president, JUST, Malaysia, Dr Ali Hossain Zadeh,


The conference-cum-solidarity iftar for Kashmir and Palestine – jointly hosted by Legal Forum for Kashmir (LFK) and IPS – was followed by the launching of a report by LFK titled 'India's Impunity in Kashmir: Surveillance, Counter-Insurgency & Politics of Fear', which throws light on the systematic use of surveillance, counter-insurgency measures, and political repression by India against the people of Kashmir.

The event was addressed by Chairman IPS Khalid Rahman, Prof Dr Amna Mahmood, dean, Faculty of Social Sciences, International Islamic University, Islamabad (IIUI), Advocate Nasir Qadri, executive director, LFK, Senior Hurriyat leaders Ghulam Muhammad Safi and Mehmood Ahmed Saghar, and Abdur Rasheed Turabi, a former politician.

High electricity prices stretching consumers' affordability to breaking point, adversely impacting DISCOs recovery



Rising electricity tariffs are increasingly moving beyond the affordability of the masses and adversely impacting their consumption patterns. This alarming trend is also causing a sharp decline in the recoveries of distribution companies (DISCOs) which can lead to difficulties in paying for

power purchases from the generation companies, maintaining distribution networks, and servicing debts. These factors further hinder the ability of DISCOs to invest in infrastructure upgrades, provide quality services, and improve the overall reliability of electricity supply.

These are some of the findings of a nationwide survey conducted by the Institute of Policy Studies, Islamabad titled "Impact of Rising Electricity Prices on Consumer Behavior: The Case of Power Distribution Companies in Pakistan". The research study covered over 1,000 households and 140 shop owners in the top 10 cities of Pakistan.

The survey results indicate that most of the

respondents have experienced moderate to significant increase in their electricity bills in recent months. The study further highlights the correlation between the magnitude of the bill increase and the extent of consumption reduction, indicating that higher price hikes lead to more significant efforts in reducing electricity usage. However, despite the overall reduction in electricity consumption, a significant portion of the survey participants reported no noticeable decrease in their bills.

The research emphasizes effective measures to address power affordability concerns and suggests strategies for DISCOs to mitigate the negative effects of rising prices. It recommends the need for improved governance and regulatory measures in the energy sector along with affordable electricity tariffs and alternative payment options to accommodate different economic circumstances. The study also stresses the importance of addressing issues such as load shedding and raising consumer awareness about peak hours when electricity costs are higher.

There is a dire need for prioritizing education and research in national planning, as this the only way forward to address the present and future challenges.






