#### Quarter in Focus

Several multifaceted developments in the international arena were discussed at IPS during the reported quarter. The completion of ten years of CPEC, for instance, was analyzed in depth with a visiting delegation from the Institute of South Asian Studies (ISAS), Sichuan University, China, whereas the visit of the Chairman IPS to China not only provided an opportunity to share an institutional perspective on CPEC and Pak-China relations, but also provided IPS an opportunity to become a pioneering member of a Chinese initiative to create a think tanks' network on the Indian Ocean Region (IOR).

The China-brokered Saudi-Iran rapprochement was seen as a blow to the Indo-US ambitions in the Western Indian Ocean region in a separate deliberation, while the potential of Shanghai Cooperation Organization (SCO) to offer a viable alternative to SAARC was the topic of discussion in an another roundtable session.

Attended by prominent intellectuals, academics, technocrats, veterans and religious scholars, the annual meeting of IPS' National Academic Council (NAC) was the quarter's most significant activity, which deliberated on the critical governance challenges faced by Pakistan at length, while urging the rulers to fill the chronic knowing-doing gap through concrete actions.

The Institute's participation in the first meeting and workshop of the International Network of Energy Transition Think Tanks (INETTT) in Johannesburg was another highlight of the period, alongside its inclusion in PID's CVE Media Cell's Policy Working Group.

Another noteworthy seminar was held with the president of Al-Mustafa International University, Qom, Iran, who spoke about the need of contemplating the Western view of modernity through *ijtihad*.

The Institute, in addition, also held webinars with three subject specialists, two on the roadmap towards Islamic financial system in Pakistan, and one discussing the ICT policy landscape in the country.

IPS LEAD, hosted exposure visits from delegates of Fiqh Academy, Al-Imam Research Institute and Jami'a Nauman bin Sabit in the period, apart from holding an in-house workshop on Al tools for research. An oral history session of its program 'The Living Scripts' was also held with renowned ibusiness magnate and philanthropist Bashir Janmohammad.

IPS Press published a new title *Maritime* Security: Challenges & Responses in a Changing World by V/Admiral Iftikhar Ahmed Rao (retd).

Besides producing eight research briefs and reports on significant topics in the period, the Institute also brought out the 44th issue of its periodical *Nugta-e-Nazar*.



# Pakistan must overcome 'knowing-doing gap' to address governance challenges: IPS-NAC

Pakistan faces deeply ingrained governance challenges that require moving beyond suggestions to concrete and sustained actions. The knowing-doing gap necessitates a proactive stance where solutions are implemented in the form of tangible actions to address the challenges faced by the nation.

The country urgently needs to address major concerns such as poor governance, internal strife, corruption, a flawed education system, moral turpitude, environmental challenges, and healthcare difficulties. This requires consistency in government policies, addressing disparities, utilizing youth as a resource, building

narratives and national emotions, and pushing constructive change through research.

This was observed by prominent intellectuals, academics, technocrats, and religious scholars at the annual meeting of the National Academic Council of IPS on September 16, 2023. The yearly gathering aims to garner intellectual inputs and ideas from a cross-section of Pakitani intelligentsia for IPS' research and dialogue on national and international issues. Chaired by IPS' Chairman Khalid Rahman, the meeting was addressed by Prof Dr Anis Ahmed, Vice Chancellor, Riphah International

The Shanghai Cooperation Organization (SCO) has the potential to offer a viable alternative to SAARC, provided the regional problems are solved regionally. Unless the bilateral equations are settled and cohesion is maintained between member states, the future contours of SCO would remain undefined.

This was observed during a roundtable discussion titled 'Regional Cooperation in the Eurasian Region: Role of the SCO' held at IPS on July 20, 2023. The forum analyzed the significance of the SCO as a vital platform for fostering regional stability, economic development, and connectivity in the Eurasian region, with a particular focus on Pakistan, and evaluated the outcomes of the SCO Summit hosted by India on July 4.

The roundtable was addressed by Ambassador (r) Masood Khalid, Pakistan's former ambassador to China. Dr Sarwat Rauf, associate professor, NUML, Ambassador r) Abdul Basit, Pakistan's former high commissioner to India, Ambassador (r) Syed Abrar Hussain, vice chairman, IPS, Meher Kashif Younis, veteran industrialist and former senior vice president Lahore Chamber of Commerce & Industry, Dr

Faisal Javed, assistant professor, FUÚAST, Karachi, and Prof Dr Fakhr-ul-Islam, director research and academic outreach, IPS. Underscoring the potential of the SCO. Ambassador Masood said that the organization has gained strength as compared to SAARC and ECO. The expansion of the SCO after inclusion of Iran along with the geographical spread of dialogue partners and observer states rooting for multipolarity instead of pledging to US-led Western domination has added a new dynamic to the evolving regional architecture of the SCO.

The session was addressed by Ghulam Mohammad Safi, Hurriyat leader, Khalid Rahman, chairman, IPS, Ambassador (r) Syed Abrar Hussain, vice chairman, IPS, Advocate Nasir Qadri, executive director, LFK, Farzana Yaqoob, former AJ&K minister and general secretary IPS-WGK, and Prof Dr Fakhr-ul-Islam, director research and academic outreach, IPS, among others.

Khalid Rahman underscored that the current situation demands that Pakistan should shape the narratives and awareness of the P5 states and international organizations to make them realize their role in this issue.

# Iran-Saudi rapprochement termed blow to Indo-US ambitions, hope for regional peace, progress



The China-brokered Saudi-Iran rapprochement is a blow to the Indo-US ambitions in the Western Indian Ocean region, especially the Gulf. It also provides an opportunity for Pakistan in terms of benefits beyond economic development, including mitigation of proxy wars and sectarian conflicts.

Regional security analysts and academics observed this at a session titled 'Iran-Saudi Rapprochement: New Power Dynamics of the Middle East' organized on July 26, 2023.

The speakers and discussants included Ambassador (r) Javed Hafeez, as the keynote speaker, Ambassador (r) Syed Abrar Hussain, vice chairman (academics), IPS, Prof Dr Nazir Hussain, former dean, social sciences, Quaid-i-Azam University, Islamabad, Dr Amna Mahmood, dean, social sciences, International Islamic University Islamabad (IIUI), Prof Dr Fakhr-ul-Islam, director research & academic

outreach at IPS, and IPS' research fellows Dr Tughral Yamin, Brig (r) Said Nazir and Dr Azhar Ahmad.

The Saudi Arabia-Iran rapprochement has rekindled hope for a positive future of the geopolitical environment of the Middle East and its peripheries, and socioeconomic progress of the larger region, the experts concurred.

Analyzing the significance of the restoration of diplomatic ties between Iran and Saudi Arabia, Ambassador Javed mentioned that this development and the peacemaking role of China, in contrast to the war-waging approach of the US, has changed the region's geopolitical landscape.

# All stakeholders must own, take responsibility to adopt Islamic financial system: Expert

Pakistan can develop and reshape its economy and financial system based on Islamic principles, provided the state and all stakeholders demonstrate absolute acceptance and support for the purpose. The executive, legisla-

ture, judiciary, policymakers, regulators, media, clergy, political parties and market players should demonstrate the willingness, take responsibility to adopt Islamic financial system.

This was emphasized by Farrukh Raza, Group CEO at UK-based Islamic Finance Advisory and Assurance Services (IFAAS) and co-founder IFN Services, during a detailed presentation on 'Road Map for Conversion Towards Islamic Financial System in Pakistan: Enabling Mindset and Strategies', held at IPS on August 31, 2023 as part of a project on mapping the Islamization of Pakistan's economy.

Raza emphasized the need for government policies and legislation to transform the finance

industry in line with Islamic principles, urging federal and provincial governments to create policies and enact laws reshaping the legal framework. To maintain the integrity of Islamic finance practices, robust regulatory supervision, corporate and Shariah governance laws, capacity-building initiatives targeting stakeholders, and raising public awareness are crucial for promoting a comprehensive understanding of Islamic finance, he added.

The transformation journey involves exploring sovereign funding tools like Sukuk, adjusting financial institutions to align with Islamic principles, and integrating Islamic funds with the economic development needs of the country, he stated.

Raza said that despite prevailing challenges, establishing Islamic finance is certainly feasible in Pakistan. The Islamic finance industry can achieve tremendous development; for that, obstacles must be overcome with dedication, coordinated efforts, and a clear plan, he added.

Talking about the IT policy landscape in Pakistan, Humayun Zafar stated that the biggest concern is that the policies are designed in a way that restricts the sector rather than facilitates them. Most of the time, it is due to the lack of vision, a clear roadmap, and a predefined target goal behind policy formulation. He stressed that policies must be developed to promote an orderly environment conducive to innovation and conflict resolution rather than to create hurdles and impediments.

#### IPS join hands with RIIO to form network of think tanks on **Indian Ocean Region**



IPS has become part of a pioneering effort by a Chinese institution to create a multilateral cooperative network of think tanks of the Indian Ocean Region (IOR). The development was a result of a bilateral Mot signed by IPS in Kunming, China with the Research Institute for Indian Ocean Economics (RIIO), Yunnan University of Finance and Economics (YUFE). The initiative was launched during the 8<sup>th</sup> RIIO international conference on 'Common Development of China and Indian Ocean Region' held with the thomas of 'Challan Ocean Region' held with the theme of 'Challenges and Prospects of Blue Economy Cooperation in the Indian Ocean: from the Perspective of Security and Development', which was hosted by RIIO-YUFE on August 18-19, 2023.

Apart from IPS, the event was attended by top officials of the School of International Studies, Jawaharlal Nehru University (SIS), India, Center for Economic and Social Development (CESD), Myanmar, Centre for Policy Dialogue (CPD), Bangladesh, and Pathfinder Foundation, Sri Lanka. The participating institutions have also signed a letter of intent to become part of the network after


necessary formalities.


