Quarter in Focus

The final quarter of FY2021-22 at IPS witnessed a continuity and consistency in the efforts to enhance institutional outreach and networking – especially focusing on policy-academia linkages – to help create an ecosystem of stakeholders, collectively shaping the policy environment in Pakistan. The universities and academic institutions across Pakistan, that IPS interacted and collaborated with during the quarter to organize seminars and generate evidence-informed dialogue, included the National Institute of Maritime Affairs (NIMA) at Bahria University, Fatima Jinnah Women University, Quaid-i-Azam University, Islamia University of Bahawalpur, University of Gwadar, University of Turbat, National University of Model Languages (NUML), University of Karachi, and Lahore University of Management Sciences (LUMS).

The most important highlights of the reported period are the detailed visit of IPS team to Gwadar and Turbat, signing of MoUs with the universities there, holding sessions with their students and faculty members, and organizing a two-day media conclave and roundtable in collaboration with the University of Gwadar, China Overseas Ports Holding Company (COPHC), Gwadar Port Authority and Gwadar Development Authority to review the CPEC-linked CSR projects in the port district. The visit was particularly beneficial in this regard as it provided the team led by IPS' Chairman Khalid Rahman - an opportunity to meet the political and civil society leadership of the Makran region. Sessions were also held with the Gwadar Bar Association, Rural Community Development Council (RCDC) and The Gwadar Post, a local media organization, where views were exchanged on issues of mutual interest. A soft launch of IPS' recent publication Balochistan ki Surat-e-Haal: Masayel ki Nauiyat, Asbab aur Hal, authored by Professor Khurshid Ahmad, was also done during the visit.

On the economic policy front, apart from continuing its tradition of reviewing the draft federal budget and enabling an exchange of views by senior experts, the Institute also organized a roundtable which lauded Federal Shariat Court's judgement on Riba-free economy, published a paper on its findings, and had an insightful discussion at the Council of Islamic Ideology (CII) on its undergoing project on Islamic Social Finance.

A roundtable discussion contemplating on the ambiguities in Transgender Act 2018 was also addressed by a representative of the Khwaja Sara community.

The first issue of the 19th volume of the flagship journal of IPS, *Policy Perspectives*, was also published during the quarter, along with an issue each of *Maghrib aur Islam* and *Nuqta-e-Nazar*.



Two-day media conclave and roundtable in Gwadar reviews CSR projects, socioeconomic development under CPEC

The initiatives in the domain of Corporate Social Responsibility (CSR) undertaken by China Overseas Ports Holding Company (COPHC) and other Chinese firms in Gwadar are appreciable and are aimed at the right direction; however, effective development communication and positive engagement with local communities is critical for the effectiveness and long-term success of these projects. All stakeholders should devise a mechanism for an integrated socio-economic development strategy and ensure inclusion of the hopes and aspirations of the inhabitants of Gwadar vis-à-vis CPEC.

This was the crux of a two-day media conclave and roundtable conference 'CSR Initiatives in Gwadar (The Gateway to CPEC)', co-organized by IPS and the University of Gwadar in collaboration with COPHC, Gwadar Port Authority (GPA) and Gwadar Development Authority (GDA) in the strategic port town on May 18-19, 2022.

World Oceans Day seminar advocates holistic approach, int'l laws for conservation of oceans

FSC Judgement on Riba-free Economy lauded

The much-awaited verdict of the Federal Shariat Court (FSC) on interest-free economy, despite being overly delayed, sets the course in the right direction by cogently answering all reservations put forward earlier. The decision, by validating the practical viability of an interest-free economy, has opened up new opportunities for the realization of this dream, and should be treated as a stepping-stone by the government and all stakeholders collectively to further build upon.

This was the consensus view of the participants of a hybrid roundtable, organized by IPS, on April 29, 2022 to discuss the way forward following the FSC judgment prohibiting and eliminating interest in all its manifestations. The session, chaired by Khalid Rahman, chairman IPS, was joined by a galaxy of experts, policy practitioners, scholars and Islamic banking and finance industry leaders

Political instability root cause of all troubles, constitutional supremacy critical: IPS-FJWU Seminar

The figures in the provisional budget, presented on June 10, are extremely fluid and would not remain the same in the final budget that will be approved at the end of the month. At this time, the political instability, which is coinciding with the economic instability, has created a critical situation for efficient budget planning and approval.

This was observed during a hybrid seminar titled 'The Federal Budget 2022-23: A Review', organized by IPS on June 16, 2022 to evaluate the federal budget for the next fiscal year and its apparent policy direction,

The session – co-chaired by Professor Dr Abdul Saboor, dean, Social Sciences, PMAS Arid Agriculture University, Rawalpindi, and Khalid Rahman, chairman IPS – was addressed by eminent economic policy analysts including the Department of Law, Fatima Jinnah Women University (FJWU) at the latter's campus in Rawalpindi on May 31, 2022.

The seminar was co-chaired by Khalid Rahman, chairman IPS, and Prof Dr Azra Yasmin, dean Faculty of Law, Commerce Management and Administrative Sciences, FJWU, and moderated by Dr Nadia Khadam, assistant professor and in-charge, Department of Law, FJWU.

The speakers included Dr Ijaz Shafi Gillani, chairman, Gallup Pakistan and Gillani Research Foundation Pakistan, Dr Aziz Ur Rahman, director, School of Law, Quaid-i-Azam University and Dr Shahzad Iqbal Sham, senior research fellow at IPS and author of recently published book Aa'een-e-Pakistan 1973 aur Islam: Martial Law, Adaliya aur Parliman ka Kirdar.

The legislative developments in Pakistan on the transgender persons have caused confusion and chaos instead of guaranteeing the rights of the marginalized gender variant population in the country. The Transgender Persons (Protection of Rights) Act, 2018, has been legislated without recourse to local realities, cultural implications, and judicious safeguards.

"We must prioritize people over infrastructure development. Drinkable water and electricity is the top priority of the authorities in Gwadar", he stated. Kashani said a desalination plant of about 1.2 million gallons would become operational in six to eight months that would provide drinkable water for the locals.

Moreover, the newly inaugurated state-of-the-art Pak-China Vocational & Technical Training Institute will provide three years' training to local youth, which is a big contribution by our Chinese friends, he added

"Chinese authorities have also recently provided 3,000 solar panels to the poorest of the poor in Gwadar for the provision of electricity." he informed.

While delivering the keynote speech, Zhang Baozhong, Chairman COPHC, spoke at length about the experiences of his seven-year stay in Gwadar.



One of the most important and fundamental values of Western civilization is the freedom of an individual. But in the

last two decades, and in recent years in particular, the tendency of Western governments, institutions and some scholars regarding the hijab seems to contradict this value of the West itself.

As Muslim immigrants have turn to the West, the Western societies, intellectuals, and government laws have increasingly been taking a hard line against the hijab. However, there is a section in the West itself that is critical of this trend and the measures that point to it.

The scholarly articles in this collection examine Islamophobia, the veil, the hijab, and restrictions on the construction of mosque minarets in Western and some Muslim countries. These articles point out why the West continues to be confused about the hijab, despite the general concept of individual freedom? Also, what kind of problems the laws and administrative measures related to hijab in the Western countries are being caused to the Muslim citizens, immigrants and tourists of these countries. Adopting a secular interpretation under the influence of Western thought, some Muslim countries are also imposing restrictions on Muslim women in terms of dress and seemingly preferring secular values over Muslim society, culture and civilization.

This Western narrative can only be countered and refuted by its critique of the arguments of the Qur'an and Sunnah and the unforgivable narrative of Muslim sociologists. Unless Muslim scholars present their narratives on the basis of scientific arguments with an awareness of these ground realities, young Muslim men and women will be influenced by Western narratives and remain skeptical about their religion.
